#### The Chatham House Rule

What is the Chatham House Rule?

The Chatham House Rule is used worldwide to facilitate both free speech and confidentiality at meetings.

Meetings may be held "on the record" or under "the Chatham House Rule". In the latter case, it may be agreed with the speaker(s) that it would be conducive to free discussions that a given meeting, or part thereof, should be strictly private. When a meeting, or part thereof, is held under the Chatham House Rule, participants are free to use the information or opinions disclosed to them, subject to two conditions.

- a) Neither the identity nor the affiliation of the speakers, nor that of any other participant at that meeting may be revealed.
  - b) It may not be divulged that the information was received at that meeting.
